Our fees are worked out on a termly basis and invoiced over 12 equal monthly payments. Payments are due in advance on the 1st of every month. Payments made after the 1st will result in a 10% late payment fee added onto your next invoice.

No collection service will be provided on public holidays. No refunds will be given for absenteeism or illness of child / children. The latest collection time in the afternoon is 5pm.

One month's written notice or one month's payment is required when terminating this service.

Scheduling is important. Please advise at least the day before or as soon as you know :

- if your child is not at school on any given day.
- if they have sport / extra curricular activities / an alternate pickup time.
- if you have made other arrangements for their collection or drop off.

This allows us to update our schedules and prevents unnecessary panic.

Vehicle rules include the need to wear seatbelts at all times and no eating on the vehicle. Damage to the vehicles made by learners will be for the account of the parents. Should the vehicles be stopped by traffic authorities and any learners be found not to be wearing their seatbelts, then any fines imposed will be payable by the learners.
